Ratepayers Werribee South is a local group which advocates for the community in the Werribee South area of Iramoo Ward . Our most recent meeting was attended by Cr Heather Marcus who advised us to submit pre-budget proposals for Council consideration.

Following the recent construction of a footpath on the north side of Beach Rd between Finch Rd and O'Connors Rd a pedestrian crossing was placed where it does not link with any facility on either side.


We feel that this crossing should have been placed at the off- branch from the foreshore footpath connecting with the off-branch from the new footpath near O'Connors Rd.

This location is more appropriate as there is convenient access to the bus stop, public toilets and the "Ängler's Anchorage" shop.

We propose that a new pedestrian crossing be placed at this location.

RATEPAYERS WERRIBEE SOUTH 2016/2017 PRE-BUDGET SUBMISSION FOR COUNCIL CONSIDERATION NORMAN-NOLAN ACCESS FOOTPATH TO BEACH RD

Ratepayers Werribee South is a local group which advocates for the community in the Werribee South area of Iramoo Ward . Our most recent meeting was attended by Cr Heather Marcus who advised us to submit pre-budget proposals for Council consideration.

In the Werribee South residential community, a full construction of a footpath in the right of way between Nos. 1 and 3 Beach Rd has become urgent.

Several residents are elderly and/or disabled and require adequate access to the bus stop opposite No.5 Beach Rd.


The laneway is also used by schoolchildren accessing the school bus on the opposite side of Diggers Rd.

The existing surface of loose rock screenings is difficult to negotiate with a wheelchair, wheeled frame or pram/pusher and there are no ramps(pram crossings) over the kerbs at either end.

We propose a 2m wide concrete shared pedestrian/bicycle path, as it is used by cyclists to connect with the shared track on the south side of Diggers Rd.

We are aware of current budgetary constraints but Council's favourable consideration of this item for inclusion in the coming budget would be appreciated.

Re: Draft Council Budget 2016/17

Wyndham,

In response to your call for submissions on the draft of the 2016-2017 Budget, Bicycle Network makes the following comments.

We, with help from our members, are assessing bicycle expenditure by local councils across Australia. This will generate a 'BiXE' (Bicycle Expenditure Index) rating – a figure which shows the amount of bicycle related spending per resident.

We have calculated the BiXE for Wyndham's draft 2016-2017 budget as \$5.24 per person, which is above the threshold of \$5 per person per year.

Bicycle Network commends your commitment to cycling, with special mention of the bicycle bridge over the Princes Freeway.
