## Introduction

Affordable housing, geographic appeal, high birth rates, increased migration and major infrastructure investments are driving forces behind Wyndham's position as the epicentre of western Melbourne's population growth. This growth will transform Wyndham from a City of 257,028 people in 2018 to nearly double in size to 489,379 by 2041. According to the latest ABS data between 2016 and 2017, Wyndham was Victoria's largest growing municipality, increasing its population by 14,092 people, or 6.2%.

This population growth is placing continued pressure the infrastructure and services needed by Wyndha residents. An important example of this pressure, explained in further detail in this budget proposal,

the growth in school aged children in Wyndham, w currently exceeds that of other Melbourne growth Councils such as Cardinia, Casey, Hume, Melton a Whittlesea. An estimated 150,000 children will atte school in Wyndham over the next 20 years, yet on average children in Wyndham's growth areas have access to half the number of primary and seconda schools compared to Greater Melbourne.

Wyndham City wants to work closer with the Victor Government on the planning and designing of community infrastructure. Not only is this the stand the Victorian Auditor General, adopting planning processes that allow for adequate input from local Councils will help the government allocate limited resources where they are needed most and provid better outcomes for our residents.

Wyndham represents an opportunity for the Victori Government to showcase its ability to support sustainable growth and invest in projects that will change the face of Melbourne's West.

# Budget submission summary

The below priorities are aligned with Victorian Government priorities as detailed in the Victorian Infrastructure Plan and The Metropolitan Planning Strategy, and are consistent with the strategic directions of the Wyndham City Plan 2017-2021 and the Wyndham 2040 Vision.





#### Victorian Government Objective(s)

- · Consult communities to identify future bus service needs, including planning for new routes and addressing links with other public transport modes

#### **3.1 Sayers Rd Railway Station**

Following the successful bid for an A-League team to be based in Tarneit, led by Western Melbourne Group and Wyndham City, the construction of the Sayers Rd Railway Station in Tarneit needs to be brought forward to capitalise on this economic development opportunity. Delivering this station will allow for greater access to the privately funded 15,000 seat stadium being built and will enable business and communities in the area to thrive.

#### **3.2 Ison Road Overpass Bridge**

Wyndham City strongly supports the construction of the Ison Road Overpass Bridge which is the last section needing a funding commitment in delivering a major road connection. VicRoads has prepared a business case detailing the approximately \$40 to \$50 million remaining to deliver the duplicated four lane overpass. Further, cost savings could be made if a four lane, duplicated road and upgrades to the Princes Highway intersection and Princes Freeway ramps are built concurrently and included in this package. This project is outlined as a priority project in the Wyndham West Development Contributions Plan and is expected to ease congestion on many arterial roads in the Wyndham West area.

#### **3.3 Regional Rail Link Stations**

Wyndham City is leveraging the \$4 billion investment already made by the state government in the Regional Rail Link (RRL) project by preparing investment frameworks for train stations along its two rail corridors. In addition to land use planning around existing stations, there is a need to deliver new stations along these corridors to ensure that our infrastructure has sufficient capacity. These sites have been identified as catalysts to ensure the adequate provision of housing, employment and economic development needed to support growth and changing demographic patterns is provided; the Black Forest Road and Davis Road sites are probably the most critical in this regard.

#### **3.4 Priority Level Crossings**

Wyndham City seeks a commitment from the Victorian government to bring forward the removal of the level crossing in Hoppers Crossing as part of the next package of funded removals. The road network connecting to this crossing is complex and delays are a great concern. We recognise these investments are significant and should be sequenced carefully with advance budget

preparation; Hoppers Crossing grade separation alone is estimated at \$150 million. The Hoppers Crossing level crossing will open up the connection between Hoppers Crossing, Hoppers Crossing railway station, and parts of the East Werribee Employment precinct.

#### **3.5 Bus Service Extensions**

Bus Service Extensions are urgently required into new residential subdivisions being approved in the growth areas of Wyndham. Between June 2015 (when Regional Rail Link opened and new bus routes were introduced across Wyndham) and September 2017, more than 13,000 lots were certified, 11,000 lots had statements of compliance issued, and 9,264 building permits for residential dwellings were approved. Many of the lots are within large new subdivisions which are located between 400 metres and four kilometres from the nearest existing bus route.





#### **3.6 Avalon Airport**

Avalon Airport's Master Plan (2015) outlines its longterm plans for the development of the airport as an international aviation centre of excellence, with four pillars of activities such as freight operations. Wyndham City supports the master planning process and the progression of major projects that will meet its strategic objectives in 2019-20 and into the future.

#### **3.7 Outer Metropolitan Ring**

Wyndham City recognises the importance of and supports work towards the 100-kilometre-long highspeed transport link for people and freight in Melbourne's North and West. The Outer Metropolitan Ring advances our city's economic growth, liveability and employment prospects and we will collaborate with any planning issues as required to ensure progress towards the project's delivery.



#### **3.8 Major Road Intersections**

Wyndham City is calling for several dangerous and congested road intersections to be upgraded including Point Cook and Sneydes Roads in Point Cook, Derrimut and Hogans Roads in Hoppers Crossing, Wattle Avenue and Princes Hwy in Werribee, Ballan Rd and Evergreen Dr in Wyndham Vale and Ballan Rd and McGrath Roads in Wyndham Vale. We are also calling for the funding of signal loops on Edwards Rd in Werribee as part of the Western Roads Upgrade Project. Council has consistently raised the issue of upgrading and signalising the Point Cook and Sneydes Roads intersection with the Victorian Government and VicRoads and was disappointed to see that no commitment was made in the lead up to the 2018 Victorian election. The Derrimut and Hogans Roads intersection also requires an urgent upgrade in order to reduce local traffic congestion and improve safety for drivers.

#### **3.9 Extra Train Stations and Services**

Wyndham City welcomes the Suburban Rail Loop as a major project that will help reduce traffic congestion throughout Melbourne. The Werribee Line and Regional Rail Link are already at capacity however and extra services are urgently needed to meet demand. Additional stations between Werribee and Sunshine are needed to improve connections for people travelling throughout the West.

#### 3.10 Western Rail Plan

Wyndham City welcomes the Victorian Government's proposed Western Rail Plan and encourages the delivery of a rail link between Werribee and Wyndham Vale to benefit people travelling between Werribee, Sunshine and Geelong. This link will allow more established parts of Wyndham to connect with developing areas, enabling residents to more easily access employment hubs, spurring local employment opportunities.



#### **4.1 Youth Violence Prevention**

Recent incidents of youth violence in Werribee, Tarneit, Williams Landing and Wyndham Vale have attracted significant community concern. Residents have reported feeling unsafe in their communities. There is an urgent need to addres issues related to violence and crime, perpetrated by a small number of young people. Intensive coordinated planning, endorsed as best practice by State Government departments, has resulted a more comprehensive approach to coordinated services and outreach across municipalities. However, support agencies, including Wyndhan City's Youth Services, have noted that their staffing and resources have been stretched beyond capacity to provide this additional coverage.

Following a collaborative process with a range o key stakeholders, Wyndham City has determined that \$1.765 million is needed to support the following programs:

- \$200,000 to provide additional resources to enable Community Support Organisations to deliver general youth worker services across Wyndham on weekends and after hours.
- \$650,000 to provide a resource to establish Wyndham youth day program accessible by young people affected by alcohol and drugs.
- \$20,000 to provide additional resources for the South Sudanese Wardens to enable greater outreach capacity.
- \$800,000 to resource a Community Support Organisation to establish a skilled multidisciplinary, early intervention, assertive outreach youth team targeting young people of South Sudanese background who have come to the attention of police as engaging in minor and serious anti-social activities.
- \$95,000 to provide additional resources to a Community Support Organisation to provide targeted Settlement Grant supports to refugee families as required beyond the current fiveyear time limit.

Wyndham City is seeking a \$10 million commitment from the Victorian Government to fund the land acquisition and design of a Family Violence Support and Safety Hub, also known as The Orange Door, in Tarneit. The establishment of these hubs was a recommendation of the Royal Commission into Family Violence, with the Victorian Government committing to build 17 of them at a cost of \$448 million. Despite Wyndham's current lack of resources and growing rates of family violence, the municipality has not been identified as one of the pilot sites for Family Violence Support and Safety Hubs across Victoria.







# 5 Schools

Wyndham City is working in collaboration with the Department of Education (DET) to develop strong forward planning and co-located infrastructure opportunities for schools to service our fast-growing communities of children and young people. There is an urgent need to address current and imminent capacity shortfalls. Detailed below are a number of projects and programs, many of which are in Precinct Structure Plans (PSP), that need to be funded and/or fast-tracked in Wyndham's growth areas.



### Summary of priority schools – 2019-20 State Budget

#### 5.1

Priorities for land acquisition:

- 1. Truganina North 7-12. This school is needed today as students have no year 10-12 opportunity in the surrounding area.
- 2. Williams Landing Primary School. There is currently no land earmarked for a future government school.
- 3. Point Cook West P-9, including an integrated specialist inclusion hub with 50 places.
- 4. Riverdale East P-6 (Tarneit), including an integrated specialist inclusion hub with 50 places.

## **6 Employment**

#### **6.1 East Werribee Employment** Precinct

Wyndham City is seeking progress on the East Werribee Employment Precinct (EWEP, including the Australian Education City (AEC). This major project will bring 58,300 jobs to Wyndham, provide space for 7000 dwellings and help drive the Victorian Government's vision of creating 20-minute neighbourhoods in Melbourne. Since identifying the AEC consortium as the preferred bidders to deliver a \$30 billion education, research



and employment city at the 775-hectare site, there have been no further announcements on its future. A project of this scale is needed in Wyndham to help boost employment, reduce traffic congestion on local roads and deliver on the Victorian's own objectives for making Melbourne more liveable. Wyndham City is ready to work collaboratively on EWEP to achieve the most efficient and effective planning and economic development outcomes.
