



## Pokie Venues in Wyndham 2018-2019



The Index of Relative Socio-Economic Disadvantage (IRSD) considers factors such as low income, high unemployment, jobs in relatively unskilled occupations and low educational attainment. All areas are ordered from lowest to highest index score. The lowest 10 percent of areas are then given a decile number of 1 (most disadvantaged), the next lowest 10 per cent of areas are given a decile number of 2 and so on, up to the highest 10 per cent of areas which are given a decile number of 10 ( least disadvantaged )

1. To benefit from 8.33% discounted tax rate, licensed Club venues submit Community Benefit Statements (CBS) to Victorian Commission for Gambling and Liquor Regulation. Amounts presented in table include direct donations, gifts, sponsorships, voluntary services and RSL support claimed by Wyndham's 6 licensed club venues. Amounts for operational costs, including facility provision and maintenance; administration costs such as wages and superannuation; marketing and promotions which can been claimed as part of the CBS scheme are not included. Club venues are also exempt from corporations tax. Full details of amounts claimed can be found at <u>VCGLR Community Benefit Statements</u>

2. The Australian Leisure and Hospitality Group Pty. Ltd. (ALH) is a joint venture between Woolworths (75% share) and the Mathieson Group (25% share). Woolworths recently announced plans to merge its Endeavour Drinks operations and ALH operations to create Australia's largest standalone integrated alcohol and hospitality business. ALH currently operate three Pokie venues in Wyndham

3. The Tigers Club House increased its EGMs from 75 to 85 in May 2018; The Geelong Football Club recently sold the Brook on Sneydes to the Victoria Amateur Turf Club (incorporating the Melbourne Racing Club)
