- Allow up to two (2) weeks for Council to deliver a new bin to your property.
- If the service is to be continued in the following financial year, the optional bin charge will automatically occur on the property owner's rates notice. The form **MUST** be signed by the owner and agents must provide owners authority.
- Optional bins must not be moved from the property or relocated to another property upon cancellation.
- Acceptable forms of payment are: cash, cheque, money order, EFTPOS or credit card. A receipt will be not be posted out unless requested by the customer.
- Cancellation Policy:**
If you wish to cancel the service, please complete "Cancellation of optional/additional bin/s form" (available on Council's website), prior to 30 June to prevent the charge re-occurring in the next financial years rates notice. You have 60 days to cancel your bin/s after new financial years rates notice has been issued. Any cancellations made after 60 days will not be refunded the waste charge.
Owners in the process of selling their property are not able to cancel the optional bin service, as the new owner pays for the optional bin in the conveyancing process, (up to the end of the financial year). It is up to the new owner to cancel the bin, if it is not required.
