4. RDF Membership and 2021 meeting schedule

Justin advised that Council received 13 Expressions of Interest (EOI), including Lisa and Karen. Four application have been shortlisted and interview are currently being scheduled.

Justin advised that Lisa and Karen would be extended for a year leaving two vacant positions to be filled through the EOI process

5. Members' Reports

Julian Menegazzo

Julian reported that, as the closest resident to the site, he was having some issues noise from the RDF, which he believes is generators operating on site. It is a low frequency noise that he can hear at night-time. Simon advised that the RDF is closed overnight and that a possible source is the generators converting gas to electricity at the LMS power station on site. The generators operate 24hrs a day 7 days a week. LMS do have an EPA operating licence for the facility that is probably like Council's licence to operate the RDF.

Karen indicated that her workplace had a similar issue and the problem was solved with some noise monitoring and attenuation barriers.

Justin indicated that Council has raised the issue with LMS. LMS are in the process of organising noise monitoring to determine if the generators are the source of the noise, if so, to what level and the potential controls if required (such as attenuation barriers).

6. Industry Update

Michelle shared a link from the MWRRG website promoting the 'Bindance' film festival, delivering industry insights for councillors. Due to COVID restriction a number of online videos and presentations from industry experts was developed to share more about what happens to household wastes and recyclables.

The CRG watched a video on how recycled glass is formed into new glass bottles at Visy' glass reprocessing facility in Laverton.

7. Wyndham Waste Strategy and Waste Service Update

Simon provided an update on the Strategic Plan and primarily the planned waster recovery and bailing facility. Simon indicated that Council had gone to market for EOI on the facility equipment and design. Simon will take the EOI to Council at the end of November 2021.

Concept design for the waste recovery process and civil instruction to be completed by February 2022. The concept design will then move towards detailed design and finalised by mid-2022.


Council is having preliminary discussions around the proposed anerobic digestion component of the facility to understand how the methane generated can be linked into the existing LMS power station on site, or potential reused back within the site facility operations.

Stephen indicated that his Department is getting the new facility to the point that Council will commit to construction. He is still working with other Council's to secure the required waste tonnages required for the bailing facility operation to be feasible.


RDF Operations

Simon provided update on some resource changes at the RDF due to the estimated 3 years of rehabilitation works that Council is undertaking. Peter Gordon has moved into a Project Management role for the rehabilitation works and Matthew Whelan has moved into the Operations Coordinator role. Simon is working offline for the next 6 months or so to work on the Bailing Facility and waste collections projects and Liza McColl is acting Manager for that period.

 Performance Dashboard - tonnage, landfill gas Simon discussed tonnages and the graphs Reduction on tonnes noted in Feb this year due to contract changes. The reduction in tonnages has allowed Site to throw some resources in to rehabilitation works



Transfer station patronage has reduced due to covid and lockdowns



Karen interested to know why the data indicates such a zig zag in the green waste numbers and was there a link between bin size and a reduction in waste.

Peter indicated that waste levels might be down as people are recycling more, composting, recycling soft plastics which reduce amount of waste going to landfill Kaylene discussed broader industry changes – packaging volumes and types.

Karthik shared a couple of observations in the local community. Karthik noted that people are using green bins more (out in their gardens mowing) and lots of his friends are removing soft plastics also noting a habitual change. Stephen asked whether it was a result of more people working from home so more likely to do their own gardening rather than pay someone to do it. Karthik agreed and also discussed more use of compost bins.

Karthik also discussed hard waste. Simon indicated hard waste was collected by a contractor who sort and recycle with the rest going to landfill. Current recovery rate for hard waste is around 45%. Kaylene indicated that the reporting on recycling rate is not great at the moment. Kaylene has asked for more data and information from the contractor around this so she can evaluate.

Stephen indicated that Council looked at the hard waste collection last year. Council wants to facilitate recovery as residents become alarmed when they see how much was going to landfill. Stephen indicated Council may look at upgrading drop off points or the transfer station to increase recovery of hard waste. This is a work in progress.

Pollution Abatement Notices

Council has been working on the existing five pollution abatement notices (PAN) issued from by the EPA. These PAN notices are the result of legacy issues of the site. Council is working closely with EPA and has agreed on plans and works required to address issued raised in PANs. All PANs are available on EPA website.

Justin indicated that from the last CRG meeting Council had completed addressing one of these PANs – leaving four outstanding PANs. Neither of the remaining four PANs would be closed out in the next week.

Complaints register

The complaints register was distributed prior to the meeting. No comments regarding this. A discussion regarding noise was undertaken earlier in the Members Report

Cell 6 and Cell 7 Construction

Cell 6 construction on track for practical completion in November 2021 and Council won't commence filling until early to mid-2022.

Cell 7 design was well underway however the site focus is on the rehabilitation project for the immediate future.
