TERMS AND CONDITIONS:

1. The prices on the application are current to 30 June 2023. Fees are reviewed annually and are subject to change from July 1 every year.
2. The optional bin requests can only be made by the owner or managing agent of the property.
3. Optional bin charges are **NON-REFUNDABLE**.
4. Allow up to two (2) weeks for Council to deliver a new bin to your property.
5. Fees will continue to be charged on the rates notice until such time Council receives cancellation form and the bin is removed.
6. Optional bins must not be moved from the property or relocated to another property upon cancellation.
7. For the upgrade/change to your existing services, Council will contact the ratepayer and/or resident to organise exchange or retrieval of bins.
8. Acceptable forms of payment are cash, cheque, money order, EFTPOS or credit card. A receipt will be not be posted out unless requested by the customer.

9. Cancellation Policy:

If you wish to cancel the service, please complete "Cancellation of optional/additional bin/s form" (available on Council's website), prior to 30 June to prevent the charge re-occurring in the next financial year's rates notice.

You have a 60 days period to query optional bin charges after new financial year's rates notice has been issued. Any query after this 60 days will not be eligible for consideration of compensation.

Owners in the process of selling their property are not required to cancel their additional bin service.
