CONDITIONS OF ENTRY

The State Rose & Garden Show is a free family-friendly event hosted by Wyndham City Council, attendees must comply with the Conditions of Entry below so that everyone can enjoy the event in safety and comfort.

COVID-19

Attendees must comply with all current Victoria State Government COVID-19 restrictions.

Alcohol

The *State Rose & Garden Show* is a licensed event. Alcohol will be available for sale to attendees aged 18 and over for onsite consumption only. BYO alcohol is not permitted.

Smoking

Smoking is not permitted at the State Rose & Garden Show.

Food

Food will be available for purchase at the *State Rose & Garden Show*. BYO food is permitted.

Photography/Filming

Live streaming or broadcasting of events and/or activities held at the *State Rose & Garden Show* is not permitted. Commercial photography is not permitted without prior permission from Council. Drones are not permitted at the event, unless with prior approval from the event organisers Wyndham City Council.

Children

Children must be supervised by a parent or guardian at all times.

Pets and animals

With the exception of assistance dogs, pets and animals are not permitted at the *State Rose & Garden Show*.

Advertising and the sale or hire of Goods

Attendees are not permitted to sell or offer for sale or hire any items, nor to distribute handbills, pamphlets, notices or other advertising materials, without prior permission from Council.

Anti-social behaviour

Anti-social behaviour is prohibited. The *State Rose & Garden Show* is intended to be family friendly, safe and comfortable for all attendees. Council requires that attendees behave in a safe, responsible and courteous manner at all times.

Free activities

Many of the free activities offered at the *State Rose & Garden Show* are run by third parties. Council makes no guarantee about an activity's quality or suitability for attendees. Attendees are responsible for deciding

whether an activity is suitable for them and/or their children to participate in.

Property

Attendees are responsible for all personal property taken to the State Rose & Garden Show and must not leave their property unattended. Council reserves the right to remove any property left unattended at the *State Rose & Garden Show*.

Consent in relation to images and photographs

Directions
