# HOW REVALUATIONS AFFECT YOUR RATES

The State Government has capped the amount by which most Councils can increase their rates revenue for 2023/24 at 3.5 per cent and Wyndham City has complied with this requirement.

However, individual properties may be affected differently as the total rate revenue is distributed by the value of the property. For example, a residential property worth \$750,000 will carry a bigger share of the total rate revenue than a residential property worth \$400,000.

As required under the Local Government Act, the annual property valuations have been undertaken as of 1 January 2023 and form the basis for the 2023/24 rates calculation.

The valuation process is conducted by an independent valuer and certified by the Valuer General Victoria.

It is important to note that increases in property valuations does not mean that council gets to collect more rates, there is no windfall gain. The total amount of rates that Council receives is still capped at the State Government imposed 3.5 per cent.

The impact for individual properties will depend on how the property value has changed relative to other properties. For some properties, there may be an increase in rates higher than 3.5 per cent while others will see a decrease.

# MESSAGE FROM THE MAYOR

Wyndham City's Annual Plan and Budget for 2023-24 has now been formally adopted by Council.

It presents a vision for the Wyndham community amid ongoing economic uncertainty and was one of the most challenging to produce in recent years.

The Budget aims to deliver a more liveable city, while recognising that we are currently in an unpredictable economic environment.

Like all businesses and families in Wyndham, Council has been impacted by the cost of building materials, utility costs, interest rates and inflation.

Wyndham is now the fastest growing municipality in Australia. And while that brings many benefits, it also increases cost pressures, that's why we have prioritised the things we believe that matter most to our residents.

The Budget includes \$167 million for our Capital Works program, including \$38 million to build new roads, resurface and renew old ones and improve our Active Transport Network.

A further \$41 million has been allocated to maintain reserves and open spaces, playgrounds and key services related to the beautification of Wyndham such as mowing, watering and tree planting.

This Budget isn't just about infrastructure – service delivery is also at the forefront. We're spending more than \$432 million on key services our residents want and need including \$20 million for Kindergartens and Children's services, \$11.9 million for Maternal Child and Health Immunisations and \$10.8 million for Libraries.

The Budget includes funding for community grants totalling \$1.45 million, putting more money in the hands of community groups and organisations to run programs and events that make a difference locally.

We certainly all face many challenges but by working together we can continue to build a better Wyndham.
