

Personal Interests Returns Summary

September 2025



A Personal Interests Return is a record of private interests of a person in public office that assists in improving transparency and public trust in local government. It is a requirement under Division 3 (Sections 132 to 136) of the *Local Government Act 2020* that specified persons lodge an Initial Personal Interests Return, and Biannual Personal Interests Returns. Specified persons required to complete Personal Interests Returns are Councillors, members of delegated committees, the Chief Executive Officer, and Officers nominated by the Chief Executive Officer if they have a statutory or delegated power, duty or function.

Regulations 8 and 9 of the Local Government (Governance and Integrity) Regulations 2020 (the Regulations), detail the information to be disclosed in each return.

The following is a summary of the information required to be disclosed by a specified person on initial and/or biannual interests returns as outlined in the Regulations:

1. Details of any corporation of which the specified person is a director or a member of the governing body;
2. Details of any unincorporated associations of which the specified person is a member and performs a leadership role;
3. Details of any business partnerships or joint ventures of which the specified person is a member;
4. Details of any trusts of which the specified person is a trustee or beneficiary;
5. Details of any paid employment where the specified person (other than employment with the Council) received more than \$10,000;
6. Consultancies, contracts or agents where payments exceeded \$10,000 or higher threshold set by the Secretary;
7. Details of land located within the municipal district of the Council or an adjoining municipal district of which the specified person is an owner or holds a beneficial interest;
8. Certain shares in which the specified person owns or has a beneficial interest;
9. Details of companies in which the specified person, solely or jointly with any family members, holds a controlling interest;
10. Details of certain personal debt exceeding \$10,000, excluding debt owed to a financial institution;
11. Gifts received equal to or exceeding \$500 (applicable only to biannual personal interests returns).
